

RELEASE/WAIVER OF LIABILITY AND ASSUMPTION OF RISK TO PLAY PAINTBALL

READ AND COMPLETE ALL BLANKS – Use a separate form for each participant.

SAFETY RULES (must be read to play)

1. Always wear approved goggles at shooting range and in or near playing field. Not adhering to this rule is cause for immediate dismissal from the game.
2. Never shoot at anyone who is not wearing approved eye protection.
3. A player is emphatically disallowed from shooting at any other player showing a neutrality symbol, any non-player, any judge or any animal or bird.
4. No player may shoot at any person, object or animal outside the perimeter of the active playing field.
5. No player may intentionally shoot at any other player's head or face.
6. Observe all safety rules applicable to firearms when handling paintball markers.
7. Only paintball markers supplied by the camp may be used.
8. Shoot only paintballs from paintball markers.
9. Never shoot at another person in anger or with intent to cause harm.
10. No physical confrontation between players is permitted.
11. No going up trees.
12. No dry firing of markers is allowed in any neutral or non-playing area.
13. Do not use paintball markers until you have been versed on its use and understand such use.
14. Do not shoot across neutral or staging areas.
15. No refunds will be given if you are asked to leave because of rule violations.

THE UNDERSIGNED

1. Has asked Shiloah Springs Bible Retreat, Inc. (dba: Indian Hills Camp) to be allowed to play paintball games and acknowledges that the game involves physical exertion and other risks, and may result in injury to the undersigned or others playing the game or observing the game;
2. Is aware of the possibility of risks of injury, including, but not limited to being shot by paintball, falling, tripping, snake bite, heat stroke, insect bites & stings, poisonous plants, improper use or operation of equipment by the undersigned or any other player and others not following the safety rules. The possibility of permanent disability (including blindness or loss of hearing) or death does exist;
3. Agrees to play the game according to the rules which have been given and to follow directions given by any game referees;
4. Warrants and acknowledges that his/her physical and mental condition will enable him/her to participate safely in the game;
5. Certifies that he/she is over 18 years old or the legal guardian of the minor participant whose name is on the front of this form;
6. Authorizes use of photos, videos, name, comments, game results, etc. for promotional purposes;
7. Understands that it is his/her responsibility to wear safety headgear provided by Indian Hills and any other safety gear deemed necessary by the participant or their legal guardian.

IN CONSIDERATION of being permitted to play the game, the undersigned, on behalf of himself/herself or assigns, hereby releases Shiloah Springs Bible Retreat, Inc. and its employees from any and all actions for damages or injury however arising, including negligence of Shiloah Springs Bible Retreat, Inc., out of the playing of the paintball game. The undersigned desires and agrees to assume any and all risks.

I hereby agree to the above release and acknowledge the receipt of the referenced safety rules. I have read and understand each item and I agree to abide by the terms of this Waiver.
