TELLING MY STORY

1. Describe your life before you trusted Jesus as Savior

Be brief using important details. Say enough about Jesus so those who are listening will have a clear idea of how God worked in your life and, in turn, how they too can come to know Jesus as Savior. Think of how you will communicate the following key spiritual truths: 1) I realized I was a sinner separated from God 2) I understood that Jesus died for me and paid the penalty for my sins.

3. Describe your life since you trusted Christ and how it is now your desire to live for Him.

Maybe share a Bible verse that has encouraged you, changes that God has made or challenges you have faced that He has helped you overcome.
